

MINUTES

A Meeting of the Parish Council was held on 28th April 2023 at 7.00 pm at the Gilbert Hall, Nancledra.

The chairman declared an interest in the planning application (6a below) as a neighbour of the applicant.

3. PUBLIC PARTICIPATION (restricted to agenda items only)

A member of the church referred to the service on the 30th of April and confirmed that there would be a buffet lunch at 11:00 AM to which all would be welcome. She said the coronation service would be on the 7th of May at 10:15 AM. On the 23rd of May there would be a concert at 7:30 PM with the Mount Bay singers. As a trustee of the Gilbert Hall she confirmed that there had been a special meeting on the 17th of April when the cost of utilities had been discussed. It had been decided to install a smart meter and to increase the hire charges with effect from the 1st of June to £25 per session or £75 per day. An application had been prepared for a grant in respect of the hall's windows. Also as the community shop had now closed the Margaret Slater room would be available in future. A new trustee of the hall had been appointed and new events and classes such as fitness classes were being considered.

PA23/02131 Proposal to Modify S106 agreement dated 28th February 1997 by removing fields 1569 and 2569 from the agreement Location Amalyeor Farm Amalyeor St Ives Cornwall

The parish council felt that it was necessary to weigh up the risk of residential development of this site against the benefit to the proposed arrangement. It was felt that young people should be encouraged to take on their own business and on that basis it was resolved to make no objection to the application.

Councillor Mitchell Reported that Cornwall Council had it now appointed a new area highways officer Andy Hoskins. He further stated that St Ives Council were putting a big screen on the beach to show the coronation.

Insurance arrangements

The Clerk reported that the insurance was due for renewal on the 1st of June. He had obtained one quote from Zurich insurance in the sum of £300 which was less than half the amount paid last year. The clerk would continue to seek further quotes.

9. PARISH MATTERS

a) Update from the working group re Cledry Meadow and update on shared prosperity fund application

Councillor Hodder said that there had been 10 responses from questionnaires left in the community shop and there had been a further 10 plus responses from the online survey. He said it seemed clear that people were in favour of something along the lines which had been suggested. A number of people had indicated a willingness to volunteer. Councillor Hodder would collate the information.

Councillor Thomas-Davy said that the application form for the funding application should be sent out in May. She suggested the nature fund should also be considered. However she said that given how the project had evolved it seemed a smaller budget would now be required.

b) Update on arrangements for the Coronation of His Majesty King Charles III

Councillor Carter had attended the meeting regarding the coronation. Parents from the school had agreed to help. Cream for the cream teas was being donated. Scones and cupcakes were to be purchased. Some year 6 pupils had volunteered for stalls. 10 raffle prices had already been donated. It had been agreed that money from collections would be given 1/2 to the school and the remaining half to the children's Hospice. A lady had offered to assist with parking and Councillor Carter would look after sports. Donations of cakes were still needed. It was agreed that any money left over from the parish council's contribution would be donated to charity. It was further agreed that the parish council would purchase 6 bottles of sparkling wine together with a gift of a plant for Julia Hodder.

c) Penwith Moors Site of Special Scientific Interest (SSSI) notification – Natural England response to consultation

It was felt that there was no need to respond to the response of Natural England. The date of the board meeting on 28th June was noted. Councillor Hollow was aware that some farmers were meeting with government ministers regarding this matter. He was aware of one farmer in particular who was being seriously financially affected by the proposals.
